## **IRG Mission Statements**

The **Incident Mission** is a statement that describes the overall goal or strategy of an IRG. The mission statements are accessed through **Planning** > **Plan Summary**, on the **General** drawer of IRGs, and these statements can be changed during *Planning*.

When IRGs are used to create incidents, the mission statement is displayed on the *Incident Dashboard* to provide guidance and direct response efforts. The mission statement, along with incident-level objectives, is also used to support compliance with the HICS 2014 and ICS 2014 standards. As the incident evolves, you can change and/or update the statement to better meet the needs of the incident.

## Standard Mission Statements for HICS 2014 and ICS 2014 Plans

**Note:** With the HICS 2014 and ICS 2014 plans, several standard IRGs were combined and, as a result, these plans contain fewer IRGs than previous plans. eICS provides access to previous plan IRGs in case you want to copy and adapt discontinued mission statements.

Earthquake	To provide a safe environment for patients, staff, and visitors either within the hospital or while evacuating the hospital following an earthquake that impacts the structural integrity of the hospital or availability of services. To provide the continuation of care for patients, visitors, and those seeking care post-incident.	To provide a safe environment for staff and clients either within the facility or while evacuating the facility following an earthquake that impacts the structural integrity of the facility or availability of services.	
Evacuation, Shelter-in- Place, Hospital Abandonment	To provide a safe environment for patients, staff, and visitors within the hospital or during evacuation following an incident that impacts the structural integrity or service availability of the hospital.	To provide a safe environment for staff and clients within the facility or during evacuation following an incident that impacts the structural integrity or service availability of the facility.	
Explosive Incident	To safely and effectively respond to a pre detonation, ongoing, and post detonation explosive incident.	To safely and effectively respond to a pre detonation, ongoing, and post detonation explosive incident.

Fire	To ensure a safe environment for staff, patients, visitors, and the hospital when a fire may or may not impact the safety and structural integrity of the hospital or availability of services; and to provide the safe continuation of care for patients, visitors, and those seeking care when a wildland fire is in the area.	To ensure a safe environment for staff and clients, and the facility when a fire may or may not impact the safety and structural integrity of the facility or availability of services; and to provide the safe continuation of services when a wildland fire is in the area.

Infectious Disease	To effectively and efficiently identify, triage, isolate, treat, and track a surge of potentially infectious patients and staff, and to manage the uninjured, asymptomatic persons, family members, and media.	To effectively and efficiently identify, triage, isolate, treat, and track a surge of potentially infectious clients and staff, and to manage the uninjured, asymptomatic persons, family members, and media.	
Information Technology (IT) Failure	To provide for business continuity and availability of essential automated systems for the hospital in the event of a massive or sustained information technology failure, cybersystems compromise, or deliberate attack.	To provide for business continuity and availability of essential automated systems for the facility in the event of a massive or sustained information technology failure, cybersystems compromise, or deliberate attack.	
Mass Casualty Incident	To ensure a safe environment for staff, patients, visitors, and the facility when the number of patients severely challenges or exceeds the capability and capacity of the hospital.	To ensure a safe environment for staff, clients, and the facility when the number of clients severely challenges or exceeds the capability and capacity of the facility.	
Missing Person	To manage the process of locating and recovering a lost or abducted person, whether infant, child, or an adult from the hospital.	To manage the process of locating and recovering a lost or abducted person, whether infant, child, or an adult from the facility.	
Other	To ensure a safe environment for staff, patients, visitors, and the hospital when incident may or may not impact the safety and structural integrity of the hospital or availability of services; and to provide the safe continuation of care for patients, visitors, and those seeking care during the incident.	To ensure a safe environment for staff, clients, and the facility when incident may or may not impact the safety and structural integrity of the facility or availability of services.	
Radiation Incident	To provide a safe environment for patients, staff, and visitors within the hospital following a radiation incident that may or may not impact the safety and structural integrity of the hospital or availability of services; and to provide the safe continuation of care for patients, visitors, and those seeking care post-incident.	To provide a safe environment for staff and clients the facility following a radiation incident that may or may not impact the safety and structural integrity of the facility or availability of services.	
Severe Weather with Warning	To provide for the safety of patients, visitors, and staff during a severe weather emergency such as ice storms, snowstorms, rain, flooding, extreme heat and cold, etc.	To provide for the safety of staff and clients during a severe weather emergency such as ice storms, snowstorms, rain, flooding, extreme heat and cold, etc.	
Staff Shortage	To maintain continuity of operations in the event of staff shortage due to strikes, patient surge, or infectious disease outbreaks.	To maintain continuity of operations in the event of staff shortage due to strikes, client surge, or other circumstances.	

Tornado	To provide a safe environment for patients, staff, and visitors within the hospital before and after a tornado impacts the campus, structural integrity of the buildings and availability of normal operational services. To provide the continuation of care for patients, visitors and those seeking care post incident including the potential for full or partial evacuation.	To provide a safe environment for staff and clients within the facility before and after a tornado impacts the campus, structural integrity of the buildings and availability of normal operational services.
Utility Failure	To safely manage patient care through effective and efficient hospital operations during the loss of a major utility within the hospital.	To safely manage efficient facility operations during the loss of a major utility within the facility.
